

**WAIVER OF LIABILITY RELEASE,
HOLD HARMLESS AND INDEMNIFICATION AGREEMENT**

I wish to engage in firearms shooting activities. I understand that engaging in these activities may be hazardous, with accompanying risks of personal injury, death, and/or loss or damage to my property. In consideration of my participation in such shooting activities, and to the maximum extent permitted by law, I, on behalf of myself, my heirs, successors, personal representatives, administrators, executors, and assigns, hereby:

1. Waive and completely discharge and release any and all claims, causes of action, suits, rights, damages, costs, expenses, or obligations or demands of any kind whatsoever, against Lorna Farrow Memorial Fun Shoot/Lorna Farrow Memorial Fund/Routt County 4H Council/Routt County Rifle Club, Inc., their parent, affiliates, subsidiaries or successor corporations, and their respective officers, directors, servants, employees, agents, representatives and contractors (altogether the "Released Parties"). For any loss, damage, personal injury, death and/or loss or damage to my property resulting from my participation in such shooting activities:
2. Agree to indemnify, defend and hold harmless the Released Parties for and against any damages, losses, injuries or claims, of any nature, arising in any way out of my participation in such shooting activities; and
3. Assume all risks associated with such activities and all responsibility for medical expenses, costs and/or other obligations and other losses or injuries to me or in which I may become involved, by reason of my participation in such shooting activities.
